This fee is applicable to the filing of a Motion to Quash a foreign subpoena, Registration of a Judgment from Another District (pursuant to 28 U.S.C. §1963), Letters of Rogatory, etc.

<sup>3</sup>This fee shall apply to services rendered on behalf of the United States if the information requested is remotely available through electronic access.

<sup>4</sup>This fee is in addition to the filing fee prescribed in 28 U.S.C. 1914(a) for instituting a civil action other than a writ of habeas corpus.

### Management of Registry Funds

Description	Fee
For management of registry funds invested through the Court Registry Investment System, excluding registry funds from disputed ownership interpleader cases deposited under 28 U.S.C. §1335	10 basis points of assets on deposit shall be assessed from interest earnings
For management of registry funds deposited under 28 U.S.C. §1335 and invested in a Disputed Ownership Fund through the Court Registry Investment System.	20 basis points of assets on deposit shall be assessed from interest earnings

<sup>5</sup>No fee is owed for electronic access to court data via PACER until an account holder accrues charges of more than \$15 in a quarterly billing cycle.

<sup>6</sup>The 30-page fee limit does not apply to transcripts of federal court proceedings and non-case specific reports. Users will accrue charges for the entire transcript and non-case specific report.

<sup>7</sup>A realtime feed is the electronic data flow from the court reporter to the computer of each person or party ordering and receiving the realtime transcription in the courtroom.

<sup>8</sup>Orders placed on or before the day of the proceeding will be batched together for purposes of determining the number of feeds, and subsequent orders will be charged at the lowest page rate assessed on the previous orders.
