



ORDER

The Judicial Panel on Multidistrict Litigation has transferred to this Court for centralized pretrial proceedings actions that concern alleged defects in the Wright Medical and Microport Profemur line of modular hip implants, which were offered in titanium and cobalt chromium alloys (the “MDL”). Wright Medical Technology, Inc. and Wright Medical Group, Inc., (the “Wright Medical Defendants”) move to withdraw Katelyn A. Romeo from representation on behalf of the Wright Medical Defendants because she has left the firm of Duane Morris LLP and will have no continuing involvement in this MDL or in the matters identified in the chart attached hereto as Appendix A (Dkt. No. 107, ¶¶ 3-4). The Wright Medical Defendants state that they will continue to be represented in each case and in the MDL generally by Duane Morris LLP (*Id.*, ¶ 2). For good cause shown, the motion is granted (*Id.*). The Clerk is instructed to withdraw Ms. Romeo as counsel of record from the MDL and from each case identified in Appendix A.
